Whereas for valuable consideration hereby acknowledged as received, the Model grants the Photographer permission to photograph the Model and furthermore grant permission to use the resulting work ("the Work") according to the terms stated hereunder:

1. Any permission granted to the Photographer and Model shall extend to his/her successors, legal representatives, licensees and assigns and shall be irrevocable and perpetual without any further or additional claim for compensation by either party.
2. Permission is specifically granted for both parties for the work to be edited, altered, distorted, used in whole or in part, in conjunction with other images, graphics and text in any way whatsoever and without restrictions, excluding erotic or other explicit sites to include all pornographic media. Permission to use and license the Images for use in any Media to include commercial work for all lawful purposes.
3. Permission granted is absolute and final and shall not be subject to further inspection or further approval by the Model at any stage in the use of the Work after approval by both parties was granted for selected images and edits. The model will receive a minimum of 10 edited images without a logo in them within reasonable time.
4. Use of the Work shall be unrestricted as to location, quantity or frequency, may be for any purpose and in any medium whatsoever, whether foreseen or unforeseen at this time, except where such use is in contravention of the law.
5. Use of the Work may be in conjunction with the Model's fictitious names. When publishing any images in any format the photographer will get permission to credit the model if she sees value before any image is published. The model in turn will credit the photographer whenever using the photos, for both parties this will be true for any public media, including digital, electronic, print, television, film and any other media now known or to be invented.

6. The Photographer and the Model shall independently own all rights in the Work which shall accrue to the benefit of his/her successors, legal representatives and assigns. This allows the model and photographer to publish and sell the images in any media except if that media is sexually explicit.

7. The Model specifically acknowledges being fully aware of the nature of the photographs and warrants her consent to appear fully and/or partially nude in some or all of the photographs. The model will not pose of any explicit nor erotic images in any form. No photographs may be altered and caused to appear explicit nor erotic in nature. No photographs may be used nor sold for explicit nor erotic use by the photographer.

8. Notwithstanding the above, the following **uses** are specifically noted and agreed to, and specific **exclusions for use** listed here shall take precedence and restrict the use of the Work accordingly:

10. This Agreement shall be construed, interpreted and governed in accordance with the laws of South Africa and should any provision of this Agreement be judged by an appropriate court as invalid, it shall not affect any of the remaining provisions whatsoever.

11. The parties agree that any or all parts of this agreement may be submitted to the other party in legible and recordable electronic form and upon acknowledgement of receipt by the receiving party shall become valid parts of the agreement.

I also understand that the model is not responsible for any expense or liability incurred as a result of my participation in this session, including medical expenses due to any sickness or injury incurred as a result, this includes damage to outfits, hair and nails.

I agree that this Release is irrevocable, perpetual and worldwide. I represent and warrant that I am at least 18 years of age and have the full legal capacity to execute this Release. **I have read this release and am fully familiar with its contents.**
